Sunita VS Bandewar

Dr Sunita Bandewar has training in Anthropology and Bioethics. She was awarded an International Fellowship by the International Fogarty Centre, NIH, USA, to pursue a Masters in Health Sciences (Bioethics) at the Joint Centre for Bioethics, University of Toronto, Canada, in 2003-04. She was a senior research fellow in bioethics and global health at the University of Toronto on the initiative titled 201 Ethical, Social, Cultural Program in Global Health 201, Canada, for five years. Her engagement with health, as a field of enquiry over these past 30 years,

is primarily via empirical research and advocacy in the areas of women and health, gender-based violence, global health, and bioethics, global health, research methodology, program evaluation, and policy analysis. She is the General Secretary, FMES, and serves on the core editorial team of the *Indian Journal of Medical Ethics (IJME)*, and heads FMES' newly established programmatic platform namely, Health, Ethics and Law Institute (HEaL Institute) for Training, Research and Advocacy. She serves on the International Ethics Review Board, Médecins Sans Frontières, Geneva. She serves on the editorial board of *Health Care Analysis*.



K V Kishore

Dr K V Kishore, Director, BALM, A NIMHANS alumnus, Dr K.V Kishore has been working in psychiatry for the last three decades. Having worked in mental health during the time of a disaster, he has developed a keen interest in developing community models for mental health & incorporating life skills for health promotion. His contribution to the mental health discourse in the country is indelible, as he has developed life skills manuals for teachers to promote health among adolescents. He has also been part of the District Mental Health Programme (DMHP), wherein he

contributed to the development of self-instruction manuals to strengthen mental health care. A prominent member of the faculty of BALM, Dr Kishore brings acumen & knowledge to the institution. He played an instrumental role in the formulation of India's first national mental health policy.

Alok Sarin

Dr. Alok Sarin is a practicing clinical psychiatrist in New Delhi, with an active interest in medicine, psychiatry, ethics, society, history and literature. He has been in active clinical practice since 1985, and is currently attached as an Honorary consultant to the Sitaram Bhartia Institute, New Delhi.



Harsh Mander

Harsh Mander (www.harshmander.in) is a human rights and peace worker, writer, columnist, researcher and teacher. He works with survivors of mass violence, hunger, homeless persons and street children.

From the autumn of 2017, he established and led the important national initiative which he called the Karwan e Mohabbat (www.karwanemohabbat.in), literally the Caravan of Love. This tries to counter rising hate and fear in the country, but not with hate; instead with love and solidarity. The Karwan visits the families of those who lost loved ones to hate violence and lynching, for atonement, solidarity, healing, conscience and justice; and to promote goodwill and trust between communities. He is Chairperson of the Centre for Equity Studies, Delhi, where he founded, convenes and edits the annual India Exclusion Reports. These attempt to document the experience of disadvantaged people of the state; and on evidence-based analysis and advocacy for more just and equitable laws and policies.



Godfrey Kagaayi

Godfrey Kagaayi is a prominent lived experience mental health advocate from Uganda with over eight years of experience working with peers with lived experience of mental health conditions, servicer user groups, and NGOs to challenge mental health stigma and shame across contexts. He is the Founder of Twogere, a dynamic youth-led mental health charity in Uganda whose mission is to change the ways people think and act about mental health problems. Godfrey is an active member of the Healthy Brains Global Initiative (HBGI) Lived Experience Council, where he co-leads the evaluation workstream. He is also an executive committee

member at the Global Mental Health Peer Network. He is highly experienced in designing and implementing monitoring and evaluation strategies for organizations with extensive knowledge of digital data collection and analysis techniques to identify the potential impacts and outcomes of different strategies plus being able to make evidence-based recommendations to improve the organizational/activity/program processes.



Sridhar Vaitheeswaran

Dr Sridhar is assistant director and consultant psychiatrist, Dementia Care in SCARF (DEMCARES), Schizophrenia Research Foundation (India) – SCARF, Chennai, India. His current research is on implementing cognitive stimulation therapy for dementia in India, implementing psycho-social interventions for dementia in rural communities in India, adapting interventions for caregivers of persons with dementia in India, and using technology to support persons with dementia in India.

Ufra's work aims to help people and communities to cope up with the psychological ramifications of living in conflict-zones; while advocating for justice and human rights, and building space for positive-peacebuilding in the process. As a frontline practitioner, advisor and global expert in her field, she's also now influencing policy-level changes on these intersections with UN organizations and global forums. Ufra has presented her work, created impact and received recognition and awards from international-forums including the UN Women, International Council of Psychologists, American Psychological Association, University of Oxford (UK), Nobel-Peace-Prize forums (USA), UN (Geneva), UNDP, Clinton's Global Initiative, World Economic Forum's Global-Shaper-Hub (Shape-SouthAsia), the Swedish-Institute, Center for Peace and Nonviolence (Uni of Rhode Island, USA), Women in Security-Conflict-Management & Peace, TEDx talks, United World College International, Rotary Foundation.

He is also a co-founder of Anusandhan Trust (retired in 2013) and its institutions, CEHAT (Mumbai) & SATHI (Pune). He is a Visiting Professor at Yenepoya University, Mangalore (since 2011) and the Centre for Biomedical Ethics and Culture, Karachi (since 2010). He is a Member of the International Ethics Review Board of the Medicine Sans Frontiers (MSF) and the National Apex Committee for Stem

Cell Research and Therapy (NAC-SCRT) of the Government of India. He has co-authored and co-edited nine books - the last co-edited with Purendra Prasad, titled Equity and Access: Healthcare Studies in India, Oxford University Press, 2018 Pg 418.



Sanjeev Jain

Prof Sanjeev Jain is a retired Senior Professor of Psychiatry, Dept. of Psychiatry, NIMHANS and the Ex-Dean, Behavioural Sciences. His research has focused on genetic mechanisms of risk psychoses and severe mental illness; and the broader issues of the interfaces between psychopathology and biology.

Barbara Regeer

Barbara Regeer, PhD, is associate professor of transdisciplinary strategies for sustainable development and system transformation at the Athena Institute, Vrije Universiteit Amsterdam. Her research interests are in emerging innovative strategies for (sustainable) development, with a specific focus on the facilitation of multi-stakeholder processes, knowledge co-creation, social change and mutual learning between all actors involved, in such areas as mental health care, child and youth care, disability mainstreaming, sustainable food systems and integrated rural

development. Besides publications in the mentioned areas in international peer reviewed journals, she has (co)authored books on approaches for knowledge co-creation for sustainable development. She coordinates, and teaches in, various courses on (transdisciplinary) research methodology, science communication, policy processes and (social) innovation.
